IMPORTANT CURRENT NOTICES

****Read the back of your tax bill for instructions for payment in full or installments****

Real Estate and Personal Property Taxes—three payment options.

1. By mail—enclose your full bill and a self-addressed stamped envelope for a receipt. Or,
2. At the State Bank of Cross Plains, 1740 Business 18-151, Mt. Horeb, WI 53572, during lobby hours
Lobby Hours: Monday-Friday 8:30 AM- 5 PM Saturday 9 AM- Noon
Note: They are closing at Noon on Dec. 24, closed Dec. 25, 2018, and closed Jan. 1 and 15, 2019.

****Bring full bill with you**** Or,

3. At town hall with Rebecca Boelhower Santi, Treasurer, Sunday evenings from 6:00 to 8:00 PM or during the following dates: Dec. 23, and 30, 2018, or, Jan. 27, 2019, or by appointment (608)437-6230.

Each household is being charged a mandatory fee for weekly trash and recycling pickup each Friday; this appears as a special charge on your bill.

A summary of assessments and taxes will be available by mail if requested along with a self-addressed, stamped envelope included with payment or can be picked up at Town Hall.

DOG LICENSES State law requires every dog of 5 months old and older be licensed. License are only issued from Town Hall by mail or in person (NOT from State Bank of Cross Plains). **Make payment separate from taxes.**

To license your dog: Send:

- 1) Proof of **current rabies vaccination certificate**, information on the dog's name, gender, breed and color.
- 2) A **check made out to the Town of Springdale**. Annual fee of \$12 for each spayed/neutered dog, and \$17 for each non-spayed/neutered dog.
- 3) A **Self-addressed stamped envelope** to: Treasurer, Rebecca Boelhower Santi, 2379 Town Hall Rd., Mt. Horeb WI 53572
