**\*\*Read the back of your tax bill for instructions for payment in full or installments\*\*****REAL ESTATE AND PERSONAL PROPERTY TAXES****3 PAYMENT OPTIONS to choose from:**

1. By mail—enclose your full bill and a self-addressed stamped envelope for a receipt.
2. At the State Bank of Cross Plains -Mt. Horeb location only: 1740 Business 18-151, during lobby hours (service not offered through the drive up). **You must bring full bill with you.**
  - o Lobby Hours: Monday-Friday 9:00 AM- 5 PM
  - o They close at noon on Dec. 24, are closed Dec. 25, 2019, and closed Jan. 1 and 20, 2020.
3. At Town Hall with Town Treasurer, Rebecca Boelhower Santi, Sunday evenings from 6:00 to 8:00 PM on the following dates: Dec. 22, and 29, 2019, or, Jan. 26, 2020, or by appointment, 437-6230.

Each household is charged a mandatory fee for trash and recycling pickup [Weekly on Fridays, (Saturday on holiday weeks), and Spring Clean-up Day] this appears as a **special charge** on your tax bill.

**DOG LICENSES--** State law requires every dog of 5-months old and older to be licensed. Licenses are only issued from Town Hall by mail or in person (NOT at State Bank of Cross Plains). **Make payment separate from taxes.**

To license your dog: Send:

- 1) **Photo copy of current rabies vaccination certificate**, information on the dog's name, gender, breed and color.
- 2) **A check made out to the Town of Springdale.** Annual fee of \$17 for each spayed/neutered dog, and \$22 for each non-spayed/neutered dog. Please note the increase in dog license fee was passed by the County.
- 3) **A Self-addressed stamped envelope** to: Treasurer, Town of Springdale, 2379 Town Hall Rd., Mt. Horeb WI 53572
